- 6. I will assist the staff and volunteers in making special events of WisconSibs, Inc successful.
- 7. I will seek to identify community members whose involvement as volunteers will be of benefit to WisconSibs, Inc.
- 8. I will seek and actively engage in opportunities to do outreach regarding the programs and services of WisconSibs, Inc.
- 9. While serving on the Board, I will assume a responsibility for helping the organization develop its financial resources. For guideline purposes, it is suggested that a \$500 annual minimum fundraising commitment to WisconSibs, Inc is indicated through (a) personal financial or in-kind contribution; (b) solicited financial or in-kind donation(s); or (c) personal involvement in service to the organization.

If anything should occur during the term of my service that would prevent me from keeping these expectations of being a positive contributor to the Board, I will take the initiative to speak with the officers about a voluntary resignation to allow another to serve who is able to meet these expectations of all Board members.
