She will fulfill her duties as Executive Director both in Appleton and remotely from Middleton.

"I am honored to have the opportunity to work with the talented and passionate WisconSibs staff, Board, and volunteers. I feel grateful to follow Founder and Executive Director Harriet Redman, whose vision to provide support and services to siblings of individuals with disabilities has created an organization that is a beacon of hope and support for thousands of siblings in their unique and lifelong roles," said Ann.

Earlier this year, Harriet Redman, who founded the organization 25 years ago announced her retirement as Executive Director. She will continue in an advisory role as Sickon gets acquainted with the operations, participants, and collaborators and serve as the Director of Special Projects part-time.
